APPLICATION AND JURY REQUIREMENTS

Application is open to all fine artists and crafts people. Only fine arts and fine crafts will be accepted. **All work must be produced by the artist applying for entry and may not be imported for resale. No copies or kits will be accepted.** ALL applicants, including returning artists are juried, and must submit the following to:

- 1) 1 photo of your outdoor booth display (we need to see how the setup looks) *
- 2) 4 photos of **current** pieces of art or craft *
- 3) A photo series & detailed description explaining your art process *
*Emailed photos accepted at lakecountrywomensclub@yahoo.com. Please include business name and your website link
- 4) A completed and signed application
- 5) A completed State Tax Form S-240
- 6) Self-addressed, stamped envelope sufficient for our reply, and your photos
- 7) Check payable to LCWC for **\$100** (\$125 if applying after 6/1.) Upon acceptance, payment becomes nonrefundable.
- 8) If applicable, a separate check for Corner Booth Request, **\$40** (refundable if we are unable to fill request)
- 9) Separate non-refundable check payable to LCWC for **\$10** jury fee**
**Previous year award winners should deduct their prize amount from the booth fee. Jury fee is waived.

LIABILITY

Artists are responsible for their own exhibit and materials. The Art Festival Committee, Lake Country Women's Club and Waukesha County Park System will NOT be liable for loss or damage to artwork, display materials or vehicle(s).

COVID 19 PROTOCOLS

The LCWC will abide by the recommendations of the CDC and follow the requirements of the Waukesha County Health Department at the time of the event.

CORNER BOOTHS

Corner booth requests will be taken but not guaranteed. If you would like to request a corner booth, please mail a **separate check for \$40**.

BOOTH INFORMATION

A 12'x12' outdoor exhibit space is provided (you need a pop-up). Specific locations and requests are honored on a first come, first served basis. However, **LCWC reserves the right to assign booth locations and change the layout at any time.**

SETUP

Artists may set up **after 3pm, Friday, July 9** (security **NOT** provided) or from **6-8:30am on Saturday**. Artists are allowed to drive up to their booth but their vehicle must be moved by 8:30 am. Pets and overnight parking is not permitted in the festival area. Contact the park directly with questions. waukeshacounty.gov

DEADLINE TO APPLY

We will jury applications until the show is full.

CANCELLATION OF FESTIVAL

If weather, major disaster, or other circumstances beyond the control of LCWC cause the cancellation of the festival, participation fees will not be returned. LCWC cannot be held liable by exhibitors for the failure of the event to take place.
